
Planning Advice and Improving Engagement in Planning

We continued to deliver our free, impartial, confidential and independent planning advice and support services to people and community groups throughout the region. Demand for the service - which is part-funded by the Department for Infrastructure - remains high as people struggle to navigate the complexities of the planning system. This year we helped 36 groups and 86 individuals from all 11 local council areas.

Our advice casework covered a wide range of planning policy issues including development control and development management, and planning appeals, enforcement and complaints.



People contacted us for advice on planning policy relating to wind turbines, mushroom processing plants, infill dwellings, retrospective planning permission, housing, stables and other structures permitted in the countryside, housing in an Area of Outstanding Natural Beauty, a marine slipway, pig farming facilities and householder permitted development.




We gave advice to groups who have plans to undertake improvements and alterations to their own community facilities and helped

others who wanted to engage with the Local Development Plan preparation process.


We also continued our work with the Planning Engagement Partnership during the year. The Partnership was established by the Minister for Infrastructure in 2020 to explore how community engagement in planning could be improved.

As co-chair of the Partnership we jointly planned, designed and facilitated community and stakeholder engagement sessions and helped shape and develop the Partnership's final report and recommendations.


The report was published in March 2022 and we look forward to continuing to work with the Partnership and its members as it seeks to implement and take forward the recommendations which will ensure that communities will be able to engage more meaningfully and effectively with planning processes.



Developing a Charter for Participatory Budgeting



We began our work to put people in the lead through quality participatory budgeting in early 2020. With funding from the National Lottery Community Fund's NI Great Ideas programme the project's work this year included information and support sessions on PB to a wide range of community groups and organisations across the region, a series of learning workshops (focusing on Community-led PB; Digital and Online PB; and PB and Community Wealth-Building), and co-designing a Charter for Participatory Budgeting to promote and support the design and development of quality PB practice.






The Charter was launched in September 2022 and we will continue our lobbying work and continue to promote PB as an innovative way to engage people and make sure they are involved in decision-making processes and the allocation of resources.






Sharing our Knowledge on Community Engagement

We drew together our knowledge and experience of many varied and innovative engagement methods and techniques and formally published our **Guide to**Engagement Methods early in 2022.

Designed as an interactive resource, the Guide looks at 19 different engagement methods, their strengths and weaknesses and assesses their suitability for and effectiveness in achieving different levels of engagement. We also provide practical tips on how to apply each technique.




We first tried out this technique with Sailortown Regeneration whose historic

Partnership Working and PB for Young People

Supported by the EU's **Erasmus+ Programme** and working with partners in Poland, Spain, and England, we completed our input to the **Youth PB Accelerator** project in March 2022.

The aim of this two-year project was to increase the social commitment and empowerment of young people, identify and share good practice of Participatory Budgeting in both schools and the community, and develop a DIY manual and Toolkit to support youth PB practice.



The DIY Manual is a set of ready-made and easy-to-use tools which can be used in the preparation and implementation of school and youth participatory budgeting processes.

The Toolkit brings together learning on what builds a successful and impactful youth engagement process. It is intended to give readers an appreciation of the architecture, design, tools, and materials that are the constant



features of a participatory budget process, involving (and ideally) also led by young people.



Build Your ProjectParticipatory Budgeting — Key Stages

Stage 1: Co-design and prepare

Stage 2: Share, Inform and Support

Stage 3: Generate Ideas and Refine Projects

Stage 4: Deliberate and Decide

Stage 5: Do and Deliver

Stage 6: Reflect, Refine, and Repeat

Our input to the project also included developing a jargon-free animation to demonstrate the key elements of PB which can be easily used and understood by young people.
