Introduction

This Community Plan for Braniel has been developed by Braniel Community Association, working with Castlereagh Borough Council, the Housing Executive, local churches and other community groups in the Braniel area. This process was facilitated by Community Places, as part of its Supporting Communities in Community Planning project.

Community Planning is about those delivering public services working together with local communities and the community and voluntary sector to identify and solve local problems, improve services and share resources.

The Braniel Community Planning Process

In developing the plan, Community Places facilitated a series of workshops which enabled participants to:

- agree how they would work together;
- design and undertake a

- community survey;
- assess the results of the survey; and
- identify priorities and agree actions.

The survey findings are summarised at page 6 and the agreed actions are presented on pages 10 to 13.

Braniel Community Association

The Braniel Community
Association was formed in
February 2008 to promote
Braniel and improve facilities and
quality of life in the area. Braniel
Community Association aims to
provide for all members of the
community in Braniel. It has built
up strong working relationships
with the local church and
primary school as well as other
community organisations,
statutory agencies and the
Council.

Braniel Community Association's current projects include:

- Re imaging project which will include a new entrance feature for the estate
- Participation in the Conswater Greenway Project
- Co-operation with other local areas to share good practice and address social deprivation
- Working towards and lobbying for the provision of a much needed new community centre and sports facilities in Braniel.

Braniel Community Association looks forward to working alongside other agencies and organisations to achieve the aims set out in this Community Plan.





Braniel Community Survey

Background

As part of the Community Planning process, it was agreed to carry out a community survey to identify the needs of people in Braniel. The survey questions were developed by the Community Plan participants at the workshops facilitated by Community Places.

Survey Method and Response Rate

The survey was primarily conducted by volunteers who called door to door throughout the Braniel Estate. Volunteers visited homes in Braniel on Saturday 15 January 2011 and either helped residents to fill out the survey on their doorstep or dropped the survey off for collection later in the week. There was also a drop off box in the Centra shop and in the high rise flats, where residents could return their survey and the survey was also available online. The survey was also carried out with local groups, such as the local football team. It was advertised in

the local shops to raise awareness that the survey was taking place and prizes were provided by Castlereagh Borough Council and Charter for Northern Ireland to encourage residents to take part.

In total, 928 surveys were distributed throughout Braniel, with a response rate of 22%. The survey results are summarised below.

Community Facilities

80% of people said that Braniel needs improved community facilities and 77% of people said that Braniel needs improved sports facilities. 40% of people said that the lack of facilities for all age groups is the worst thing about living in Braniel and 60% said that they would use a sports hall or large hall.

66% of people said that a community library is needed and 59% of people said that a drop in community computer centre

is needed. 57% said that play areas and facilities need to be improved.

80% of people said that the bowling green next to the community centre should be developed as a 3G football pitch.

66% of people said that they would be interested in a drop in café and 67% of people said that if a better community centre was developed, they would use a coffee lounge.

Environment, Transport and Safety

40% of people said that an environmental issue was the worst thing about living in Braniel. 59% said that repairing and cleaning footpaths needs to be improved and 72% of people said that the problem of dog fouling needs to be tackled in Braniel. 54% said that parking facilities need to be improved.

72% of people said that public transport in Braniel should be improved by introducing more




Which of the following does Braniel need?

routes. 41% said that they would like a public transport route that goes to the Newtownards Road and 18% said they would like to see a return of the Number 24 bus.


11% of people said that a public transport issue was the worst thing about living in Braniel.

Policing and Safety

82.7% of people said that a more visible police presence would improve policing and safety in Braniel and 51.4% said that more information about police services in Braniel could improve policing and safety in Braniel. Respondents also showed concern about vandalism, graffitti and other safety issues.

Health, Education and Training

52% said that they would like to see local advice and information on drugs misuse and 51% said that they would like to see mental health awareness and support. The respondents who had people aged between 41 and 65 in their household were most likely to be interested in health and well being activities.

58% of people said that they would be interested in short training courses and 56% said that education/training classes in the community are needed. 64% said that help with finding jobs is needed. 58% of people said that basic computer classes are needed and 42% of people who indicated what type of classes they would be interested in basic computer classes.


62% of people said that they would like to see health and fitness classes in Braniel.

28% of people said that if a better community centre was developed and offered a crèche, they would use it.


57% of people said that they would be interested in social nights, such as darts, quizzes or dancing and 39% said that the lack of facilities and activities is the worst thing about living in Braniel.

Suggestions for activities in Braniel included street parties or fetes and events. 77% of people said that Braniel needs improved youth facilities. 46% of people said that Braniel needs an after school club and 34% said that they would be interested in parent support. 50% of people said that they or their family would be interested in activities for senior citizens. 67% of people said that Braniel needs improved sports facilities.

Castlereagh District Housing Plan and Local Housing Strategy 2010-2011


The following information has been taken from the Castlereagh District Housing Plan and Local Housing Strategy 2010-2011.

Braniel is located in the Castlereagh
Urban Central area which consists
of the Ballygowan Road, Braniel,
Clonduff and Cregagh areas. It
states that the social new build
requirements for Castlereagh
Central in the next five years has
been projected at 134 units. The
Castlereagh District Housing Plan
and Local Housing Strategy 20092010 states,


"Braniel is a popular estate where housing need cannot be met from existing stock."

The social housing waiting list analysis for Castlereagh Urban Central, contained in Castlereagh and District Housing Plan and Local Housing Strategy 2010-2011 shows that the majority of applications were made by "single" persons". There were also a relatively high number of applications from small families and older persons. The waiting list analysis also shows a higher number of housing stress applicants in these categories.
